Paterson Education Fund is providing scholarships for young women in Paterson to attend enrichment, particularly summer enrichment, experiences. Scholarship amounts will range from \$500 to \$1,000. Scholarships **will not** be awarded for regular school tuition. PEF has a total of \$3,000 available for 2007.

The program is open to Paterson Public Schools 7th, 8th, 9th and 10th grade girls. The program will provide support for summer courses or experiences that help them expand their interests and skills. Funds unexpended during the summer may be used for after school enrichment during the school year.

**Procedure:**

1. Only young women in grades 7-10 who reside in Paterson at the time of nomination are eligible for the scholarships.
2. When PEF receives a nomination form, staff will verify the status of the young woman and her request.
3. When possible, PEF will send a check directly to the enrichment program in the name of the young woman.
4. PEF requests a letter from the recipient reflecting on her experiences once the enrichment program is over. This letter may be used in determining further support in other years.
